ACKNOWLEDGEMENT REGARDING FEE REFUNDS

THE UNDERSIGNED ACKNOWLEDGES THAT S/HE HAS READ THE APPLICATION FOR ENROLLMENT TO HILLCREST PROGRESSIVE SCHOOL AND UNDERSTANDS THE FOLLOWING SUMMER PROGRAM POLICIES:

1. **PAYMENTS BY CREDIT CARD ARE SUBJECT TO A 2.5% SERVICE FEE ("SERVICE FEE").**
2. **DEPOSIT #1 IS AN APPLICATION FEE WHICH IS NOT REFUNDABLE OR TRANSFERABLE UNDER ANY CIRCUMSTANCES ("APPLICATION FEE").**
3. **IF YOU DECIDE TO WITHDRAW YOUR CHILD FROM A PROGRAM, YOU MUST GIVE NOTICE BY EMAILING THE SCHOOL'S OFFICE ("WITHDRAWAL NOTICE").**
4. **IF YOU WITHDRAW YOUR CHILD FROM A PROGRAM, THE AMOUNT OF ANY DEPOSITS OR INSTALMENTS PAID ARE NOT REFUNDABLE, EXCEPT IN THE FOLLOWING CIRCUMSTANCES:**
 - a. **IF YOU GIVE WITHDRAWAL NOTICE BEFORE APRIL 1, 2022, AND YOUR CHILD'S SPOT IS FILLED BEFORE DAY 1 OF THE PROGRAM, YOU WILL BE REFUNDED THE TOTAL FEES PAID, LESS: ANY SERVICE FEE(S) PAID, THE APPLICATION FEE, AND 10% OF THE TOTAL PROGRAM FEE ("VACANCY FEE").**
 - b. **IF YOU GIVE WITHDRAWAL NOTICE BEFORE APRIL 1, 2022, AND YOUR CHILD'S SPOT IS FILLED AFTER DAY 1 OF THE PROGRAM, YOU WILL BE REFUNDED THE TOTAL FEES PAID, LESS: ANY SERVICE FEE(S) PAID, THE APPLICATION FEE, AND A VACANCY FEE FOR EACH MONTH IN THE PROGRAM PERIOD WHERE YOUR CHILD'S SPOT WAS NOT FILLED FOR ANY PART OF THAT MONTH.**
 - c. **IF YOU GIVE WITHDRAWAL NOTICE AFTER APRIL 1, 2022, AND YOUR CHILD'S SPOT IS FILLED BEFORE AUGUST 1, 2022, YOU WILL BE REFUNDED THE TOTAL PROGRAM FEES LESS: ANY SERVICE FEE(S) PAID, THE APPLICATION FEE, AND A VACANCY FEE FOR EACH MONTH IN THE PROGRAM PERIOD WHERE YOUR CHILD'S SPOT WAS NOT FILLED FOR ANY PART OF THAT MONTH.**

THERE SHALL BE NO REFUNDS FOR ANY DAYS OR WEEKS MISSED.
