  - a. IF YOU GIVE WITHDRAWAL NOTICE <u>BEFORE AUGUST 29<sup>TH</sup>, 2025</u>, AND YOUR CHILD'S SPOT IS FILLED <u>BEFORE DAY 1 OF THE PROGRAM</u>, YOU WILL BE REFUNDED THE TOTAL FEES PAID, <u>LESS</u>: ANY SERVICE FEE(S) PAID, THE APPLICATION FEE, AND 10% OF THE TOTAL PROGRAM FEE ("VACANCY FEE").
  - b. IF YOU GIVE WITHDRAWAL NOTICE <u>BEFORE AUGUST 29<sup>TH</sup></u>, 2025, AND YOUR CHILD'S SPOT IS FILLED <u>AFTER DAY 1 OF THE PROGRAM</u>, YOU WILL BE REFUNDED THE TOTAL FEES PAID, <u>LESS</u>: ANY SERVICE FEE(S) PAID, THE APPLICATION FEE, AND A VACANCY FEE FOR <u>EACH MONTH IN THE PROGRAM PERIOD</u> WHERE YOUR CHILD'S SPOT WAS NOT FILLED <u>FOR ANY PART OF THAT MONTH</u>.
